ANNEXURE - I

GENERAL TERMS AND CONDITIONS

1. Earnest Money Deposit (EMD):

- 1.1 Earnest Money Deposit of Rs. 5000/- (Rupees five thousand only) by way of <u>Demand Draft</u> drawn in Bank of Baroda or any nationalized bank payable at Chengalpattu, in favour of "The Director, Central Leprosy Teaching and Research Institute, Chengalpattu" should be submitted along with the Technical Bid & Commercial Bid. <u>The EMD in any other form will not be entertained</u>. Firms registered under NSIC, DGS&D & MSME Act 2006 and those firms which are registered with the District Industries centre/Department of Commerce & Industries, Government of India & Tamil Nadu/any other State Governments which current validity are exempted from furnishing the Earnest Money Deposit (EMD). Otherwise, such bids without payment of cost of Tender Fee and EMD will be summarily rejected.
- 1.2 Bidder shall not be permitted to withdraw his offer or modify the terms and conditions thereof after submission of the tender documents. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited by the Government.
- 1.3 No claim shall lie against the Government/Department in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit. EMD will earn no interest.
- 1.4 EMD of unsuccessful bidder will be refunded only after finalization of tender selection and that of the successful bidder will be refunded only after completion of works.

2. Preparation and submission of Tender:

The tender should be submitted in two parts namely

- a) Technical Bid along with the proof of Earnest Money Deposit (in Form given in Part-I & II of Annexure-III) and
- b) Commercial Bid (in form given in Annexure-IV)

and each should be kept in a separate sealed cover. Both the bids should be kept in another sealed cover addressed to the undersigned. The envelope containing sealed cover should be super scribed with "Open Tender for Printing of documents" and addressed to "The Director, Central Leprosy Teaching & Research Institute, Govt. of India, Ministry of Health & Family Welfare, Chengalpattu – 603 001, Kancheepuram District, Tamil Nadu". The covers which are not sealed will be summarily rejected.

3. Signing of Tender:

Individual signing the tender or other documents connected with contract must specify whether he sign as:

- a) A "sole proprietor" of the concern or constituted attorney of such sole proprietor.
- b) A partner of the firm, if it be a partnership firm, in which case must have authority to execute contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by executed by the partner of the firm.
- c) Director or a principal office duly authorized by the Board of Directors of the Company, if it is a company.

4. N.B.

- a) In case of partnership firms, a copy of the registered partnership agreement and if power of attorney is executed in favour of any or all the partners of any authorized officer of the firm to sign the tender document. Then, a copy of power of attorney duly executed by all the partners, sworn in before Notary Public should be enclosed.
- b) In case of partnership firms where no authority to refer disputes concerning the business of partnership firm has been concerned on any partner the tender and all other related documents must be signed by all partners of the firm.
- c) A person signing the tender form or any documents forming part of the tender on behalf of another person should have an authority to bind on behalf of such other person and if, on enquiry it appears that the persons so signing had no authority to do so, The Director, Central Leprosy Teaching & Research Institute may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages.
- d) In case of Private Ltd/Limited companies, Company Incorporation Certificate along with the Articles of Association has to be submitted.
- e) In the case of Co-operative society, the authorized officer should furnish the authentication letter to execute the contract from the competent authority of the Registrar of Co-Operative Societies.
- f) The bidder should sign and affix his/his firm's stamp on each page of the tender documentsand all its Annexure, as the acceptance of the offer made by the bidder will be deemed as a contract and no separated formal contract will be drawn. NO PAGE SHOULD BE REMOVED/ DETACHED FROM THIS NOTICE INVITING OPEN TENDER. The tender document along with the enclosures has to be serially numbered and the number of pages should be indicated in the check list attached to the tender document.

5. Technical Bid:

The Technical bid should be submitted in form given in Part-I & II of Annexure-III and the original receipt obtained for Earnest Money Deposit (EMD) for the amount indicated in Para 1 of Annexure-I, along with full details of technical facilities for execution of the work. The technical bid should also contain all the essential documents as mentioned in Part-II of Annexure-III and as per clause in Annexure-I.

6. Commercial Bid:

- 6.1 The commercial Bid should be submitted in form given in ANNEXURE-IV. The tenders will be evaluated by duly constituted "Tender Evaluation Committee/Purchase Committee".
- 6.2. **Price Schedule** Printing of documents should be quoted along with its break up showing various items of charges. The price quoted shall be firm and final, otherwise no extra payment would be made for this purpose. Terms of payment as stated in the Tender document shall be final.

7. Criterion for Evaluation of Tenders:

The evaluation of the tenders will be made first on the basis of technical information furnished in form given in Part-I & II of ANNEXURE-III which includes:

- a. Payment of Earnest Money Deposit of Rs.5000/-(Rupees Five thousand only) as per terms & conditions.
- b. List of documents to be submitted is mentioned in Part-I & Part-II of Annexure-III.
- c. Furnishing Partnership deed/Incorporation certificate and articles of association (any one of these documents as is applicable) (see N.B. Para 4 of Annexure-I)
- d. The commercial Bid of such firms found valid based on technical parameters (as per Annexure-III) after evaluation of the technical bid. Evaluation of Commercial Bids will be based on total consolidated price.
- e. It must be kept in view that no decision will be given by the Tender Evaluation Committee/Purchase Committee or any interferences drawn during the meeting of this committee by the bidder or their representatives will be their own view and the Department will not be responsible and abide by the same. The reasons for selections or rejections of a particular tender will not disclosed.
- f. The award of work will be further subject to any specific terms and condition of the contract given in **Annexure-I** as per specification in **Annexure-II** and **II(a)** of this tender.

8. Right of Acceptance:

- a. The Director of this Institute reserves all rights, without assigning any reason whatsoever to reject any tender which fails to comply with the terms & conditions laid down in the tender. The Department does not bind itself to accept the lowest specific tender.
- b. The Director, Central Leprosy Teaching & Research Institute reserves the right to cancel any tender at any time without any assigning any reason.
- c. The decision of Director in this regard is final and binding.
- d. Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the work will prejudice the bidder's quotation and liable for disqualification.

9. Communication of Acceptance:

Successful bidder will be informed of acceptance of his tender. Necessary instructions regarding the amount and time provided for Performance Security Deposit is indicated in Para No. 10 below.

10. Breach of Terms and Conditions:

- 10.1 In case of breach of any of terms and conditions mentioned above by Successful bidder, the Competent Authority will have the right to cancel the supply/work order without assigning any reasons thereof and nothing will be payable by this Department in that event and the Performance Security Deposit shall also stand forfeited to Govt. Account without giving any notice to the bidder.
- 10.2 Any violation of terms and conditions or supply of inferior quality of items will result in total rejection of the items, apart from taking suitable remedial action at your cost & risk.
- 11. The tender is not transferable. Only one tender shall be submitted by one bidder.

12. Terms of Payment

- a. Payment will be made, only after completion of **supply of priniting of documents** to this Office
- b. If any deduction will occurred at the time of payment of bills the same will be deducted at source as per Government rules and guidelines as may be prevailing at the time of payment (wherever applicable).
