The limited tender document should be sent by Registered Post/Speed Post/By hand, so as to reach this office on or before the due date/time otherwise tender document rejected. Reason for postal delay will not be entertained and tenders received through private courier or by ordinary post /e-mail will be summarily rejected.

GENERAL TERMS AND CONDITIONS

1. Tender document:

- 1.1. The tender is not transferable. Only one tender shall be submitted by one bidder.
- 1.2 Bidders can also to submit the limited tender document in the downloaded form from this Institute website http://www.cltri.gov.in or Central Govt. Tender Portal http://tenders.gov.in.

2. Earnest Money Deposit (EMD):

- 2.1 Earnest Money Deposit of **Rs.20,000/-** (Rupees Twenty thousand only) by way of in the form of Account Payee Demand Draft drawn in Bank of Baroda or any nationalized bank payable at Chengalpattu, in favour of "The Director, Central Leprosy Teaching and Research Institute, Chengalpattu" should be submitted along with the tender document. **The EMD in any other form will not be entertained**.
- 2.2 Firms registered under NSIC, DGS&D & MSME Act 2006 and those firms which are registered with the District Industries Centre/Department of Commerce & Industries, Government of India & Tamil Nadu/any other State Governments which current validity are exempted from furnishing the Earnest Money Deposit (EMD). Otherwise, such bids without EMD will be summarily rejected.
- 2.3 No claim shall lie against the Government/Department in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit. EMD will earn no interest.
- 2.4 EMD of unsuccessful bidder will be refunded only after finalization of tender selection and that of the successful bidder will be refunded after submission of performance security deposit.

3. Tender Withdrawal & Modification: -

Bidder shall not be permitted to withdraw his offer or modify the terms and conditions thereof after submission of the tender documents. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid amount of Earnest Money Deposit (EMD) will be forfeited and credited to the Government.

4. <u>Preparation and submission of Tender:</u>

The tender should be submitted in single sealed envelope containing with two envelopes (i.e. Technical bid and Price bid in separate envelope) to the undersigned. The envelope should be super scribed with "Limited Tender (Two Bid System) for supply of Unskilled Security Guards without arms – Limited Tender

F.10/02/CLTRI/E.I/2021 dated 03.08.2021" and addressed to "The Director, Central Leprosy Teaching & Research Institute, Govt. of India, Ministry of Health & Family Welfare, Chengalpattu – 603 001, Tamil Nadu". The envelopes, which are not sealed, will be summarily rejected.

5. <u>Signing of Tender:</u>

Individual signing the tender documents connected with contract must specify whether he sign as:

- a) A "sole proprietor" of the concern or constituted attorney of such sole proprietor.
- b) A partner of the firm, if it be a partnership firm, in which case must have authority to execute contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by executed by the partner of the firm.
- c) Director or a principal office duly authorized by the Board of Directors of the Company, if it is a company.

6. Important Conditions:-

- a) In case of partnership firms, a copy of the registered partnership agreement and if power of attorney is executed in favour of any or all the partners of any authorized officer of the firm to sign the tender document. Then, a copy of power of attorney duly executed by all the partners, sworn in before Notary Public should be enclosed.
- b) In case of partnership firms where no authority to refer disputes concerning the business of partnership firm has been concerned on any partner the tender and all other related documents must be signed by all partners of the firm.
- c) A person signing the tender form or any documents forming part of the tender on behalf of another person should have an authority to bind on behalf of such other person and if, on enquiry it appears that the persons so signing had no authority to do so, The Director, Central Leprosy Teaching & Research Institute may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages.
- d) In case of Private Ltd/Limited companies, Company Incorporation Certificate along with the Articles of Association has to be submitted.
- e) The bidder should sign and affix his/his firm's stamp on each page of the tender documents and all its Annexure, as the acceptance of the offer made by the bidder will be deemed as a contract and no separated formal contract will be drawn. NO PAGE SHOULD BE REMOVED/ DETACHED FROM THIS NOTICE INVITING TENDER. The tender document along with the enclosures has to be serially numbered and the number of pages should be indicated in the checklist attached to the tender document.

f) No person agency is permitted to submit bid for tender whose relative(s) is (are) working in CLTRI, Chengalpattu in any official capacity or otherwise.

7. <u>Bid with Technical Specification:</u>

The Technical bid specifications Annexure-II Part (A) & (B) should be submitted in separate sealed envelope along with documents listed in Part (A) of Annexure-II, Annexure-IV, V and VI.

8. <u>Bid with Price Schedule:</u>

The Price Bid (Annexure-III) should be submitted in separate sealed envelope along with Demand Draft for Earnest Money Deposit (EMD) for the amount indicated in Clause 2 of Annexure-I.

9. <u>Criterion for Evaluation of Tenders:</u>

Evaluation of the limited tender (Two Bid System) based on the following parameters:-

- a. Payment of Earnest Money Deposit of Rs.20,000/- (Rupees Twenty thousand only) as per Clause 2 of Annexure-I.
- b. List of documents to be submitted as per Annexure II.
- c. The financial bid will be evaluated only for technically qualified Contractors
- d. Lowest service charge quoted by the contractor as per Annexure III
- e. Furnishing Partnership deed/Incorporation certificate and articles of association (any one of these documents as is applicable (Refer Clause 6 of Annexure-I)
- f. It must be kept in view that no decision will be given by the tender evaluation Committee or any interferences drawn during the meeting of this committee by the bidder or their representatives will be their own view and the Department will not be responsible and abide by the same. The reasons for selections or rejections of a particular tender will not disclosed.

10. Right of Acceptance:

- (a) The Director, Central Leprosy Teaching & Research Institute reserves all rights, without assigning any reason whatsoever to reject any tender document which fails to comply with the terms & conditions laid down in the tender. The Department does not bind itself to accept the lowest specific tender.
- (b) The Director, Central Leprosy Teaching & Research Institute reserves the right to cancel this Limited Tender at any time without any assigning any reason and also right to instruct the successful tenderer to provide the documents, if required.

- (c) The decision of Director in this regard is final and binding.
- (d) Any failure on the part of the bidder to observe the prescribed procedure and any attempt to canvass for the Service will prejudice the bidder's document and liable for disqualification.

11. Communication of Acceptance:

- (1) Successful bidder will be informed by telecommunication/letter/order for acceptance of their tender. Necessary instructions regarding the amount and time provided for Performance Security Deposit is indicated in Clause 12 of this Annexure.
- (2) The successful bidder will have to enter into a written Contract / Agreement with CLTRI, before commencing of contract.

12. <u>Performance Security Deposit</u>:-

The Contractor will have to deposit a Performance SECURITY Deposit for a sum of Rs.1,00,000/-(Rupees One Lakh only) at the time of placing the Contract within 15 days of the receipt of formal order. The performance Security will be furnished in the form of Bank Guarantee drawn in favour of Central Leprosy Teaching and Research Institute, Chengalpattu-603 001, TDR (Term Deposit Receipt) or Fixed Deposit Receipt (FDR) from a Nationalized Bank made in the name of Contractor Company/Firm/Agency but hypothecated to the Central Leprosy Teaching and Research Institute, Chengalpattu-603 001. The performance Security should remain valid for a period of 60 days beyond the date of completion of all the contractual obligations of the supplier.

14. <u>Breach of Terms and Conditions:</u>

- In case of breach of any of terms and conditions mentioned above by Successful bidder, the Competent Authority will have the right to cancel the supply/work order without assigning any reasons thereof and nothing will be payable by this Department in that event and the EMD shall also stand forfeited, without giving any notice to the bidder.
- In case of breach of any terms and conditions stipulated in the contract, a part or full, as the case may, of the PERFORMANCE SECURITY DEPOSIT of the Agency will be liable to be forfeited by this office besides annulment of the contract
- 3. The tender is not transferable. Only one tender shall be submitted by one bidder.
- The tender is liable to be rejected, if the service charge is quoted less than 3%.
