

Bidder must go through the terms and conditions carefully and understand them before submitting the tender. No excuse that the conditions have been read or understood will 2)

be entertained later.

EARNEST MONEY DEPOSIT:-3)

- Each tender must be accompanied by EMD Rs.7,000/- (Rupees Seven thousand only) in the form of Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee from Bank of Baroda or any nationalized bank infavour of "The Director, Central Leprosy Teaching and Research Institute, Chengalpattu". Any tender not so accompanied by the Earnest Money Deposit (EMD) is liable to be rejected. No interest will be allowed on this deposit.
- EMD of unsuccessful bidder will be returned on finalization of tender. EMD of successful bidder will be returned only after depositing the Performance Security Deposit by the successful bidder.

PERFORMANCE SECURITY DEPOSIT:-4)

- Successful bidder will be required to deposit the performance security deposit on or before the date herein fixed for execution of the agreement. Performance (i) Security Deposit of Rs.1,00,000/- (Rupees One thousand only) will be submitted by the successful bidder in the mode of Fixed Deposit Receipt (validity upto 31st March, 2022) or Bank Guarantee (validity upto 31st March, 2022) from Bank of Baroda or any nationalized bank drawn in favour of Research and **Teaching** Leprosy Central "Director, Chengalpattu".
- If the successful bidder failed to compliance on the contract and if any breach of terms & condition, the Performance Security Deposit will be forfeited to Govt. Account.
- Security deposit will be refunded, without any interest, after the date of (iii) expiry of his/her term of contract.
- Rates should be quoted separately for each eatables/beverages items as listed in Annexure -I and other items. The rate quoted by the Contractor shall be inclusive of GST. 5)

TERMS & CONDITIONS

- Rates quoted by the Contractor shall be final and applicable upto the end of contract. If any variation in the market prices, shall not be entertained.
- 7) The contract rate quoted by the bidder is inclusive of delivery charges, package charge and transportation and valid up to 31st March, 2022, as the breakfast to in-patients of various wards in CLTRI is also supplied by the Staff canteen. The break fast shall be served at <u>08:30AM</u> daily.
- The rate quoted by the bidder shall not in any case exceed the MRP or market price, if any, fixed by the Government of the reasonable price. Rate is permissible to charge a private purchase for the sample class and description of goods, under the provisions of clause 6 of the Hoarding and Profiteering Prevention Ordinance 1943, as amended from time to time. If the prices quoted exceeded the MRP or market price or the price permissible under the Hoarding and Profiteering Prevention Ordinance, the bidder will specifically mention this fact in this tender document along with the reason for quoting such higher price with proof of documents. Director of this Institute at his discretion will in such case exercise the right of revising the price at any stage, so as to verify the Market Retail Price (MRP) or market price or the price permissible under Hoarding and Profiteering Prevention Ordinance. This discretion will be exercised without prejudice to any other action that may be taken against the bidder.
 - 9) Tender cannot be accepted, if the rate quoted as "at current market rates".
 - In case, if the contractor fails to supply the item in time stating that the prices have escalated and the contractor is unable to supply, the contract will summarily be cancelled in the interest of public and the next contractor will be asked to execute the contract in the place of the original contractor.
 - 11) If the successful tenders fail to execute and or deposit the required Performance Security Deposit within the time specified or withdraw their tenders after intimation of the acceptance of their tenders has been sent to them or fail to comply with clause 10 above or owing to any other reasons, they are unable to undertake the contract, their contract will be cancelled and the earnest money deposited by them along with their tender is liable to be forfeited to Govt. Account and they will also be liable for all damages sustained by the Director by reason of such breach, including liability to pay and difference between the prices accepted by him and those ultimately paid by him for such articles. Such damages shall be accessed by the Director, whose decision is final and the amount so assessed is recoverable by proceeding under the Tamil Nadu Revenue Recovery Act 1864 (Tamil Nadu Act II of 1864) as an arrear of land revenue.
 - 12) The bidder cannot be sublet without the permission of the Director of the Institute.
 - Income Tax as required under the Income Tax Rules will be deducted from the successful bidder's bills regularly, unless a written order of the Income Tax officer concerned, specifying not to recover Income Tax is produced by the Contractor.



- The contractor shall pay electric current consumption charges according to the submeter reading together with the meter rent at the rate applicable to him on receipt of bill every month.
- The contractor will be provided with furniture for the dining room only and shall be responsible for their proper use and safe keeping of these items. If any damage, will be recovered from the Security Deposit of the Contractor.
- The contractor shall be allowed to use the existing water taps for purpose connected with the canteen. He/she shall pay a sum of Rs.250/- (Rupees two hundred and fifty only) towards water charges every month, without fail.
- The contractor shall bring his/her own utensils and crockery require for the preparation and serving to the consumers. Crockery for serving to be of quality that is suitable for serving to officials of the Institute which include high ranking officers and others.
- The contractor shall surrender possession of the premises and furniture and all other Institute properties to the CLT&RI on the expiry of the period of the contract fixed here, in the same condition as they were when they took over charge.
- 19) The contractor shall not sub-let the premises and shall not utilize the building for any other purpose, except for which it has been given on contract to him/her.
- 20) The Contractor shall be responsible to keep the kitchen, dining rooms and adjoining areas, in a clean and hygienic condition, and shall not cause any damage or structural changes to them.
- No persons other than those working in the canteen should stay in the canteen premises. Stay in the canteen premises by member of the family of the contractor his/her representative is strictly prohibited.
- The contractor shall supply unaltered and wholesome food. On surprise check, if the food served on any day is found to be lacking in quality and quantity, action as deemed proper will be taken against the contractor.
- During the period when training courses are being conducted, on demand, the contractor shall provide meals on Sundays and all public holidays to the trainees.
- 24) Acceptance of the tender will be communicated to the successful bidder.
- 25) The Director at his discretion not to accept tender document of the Contractor/Bidder who has in previous years withdrawn his tender without valid reasons.
- 26) <u>Termination of Contract</u>:- (i) The Director of this Institute will be at liberty and empower to terminate the awarded contract without assigning any reasons, therefore, the contractor will not be entitled to any compensation whatsoever in respect of such terminations.
 - (ii) If the awarded contractors fail to violating or breach of contracts during the contract period, the contract will be terminated without assigning any reason.
- The Director may at his discretion, accept or reject any tender, even though the bidder fulfills all eligibility criteria, without assigning any reason, even at the time of opening tender documents.
- 28) Contractor/Bidder should sign in the tender documents all pages along with his seal, otherwise the tender document will not be accepted and the same will be rejected.
