## GENERAL TERMS AND CONDITIONS

## Tender Form :

- 1.1. The tender is not transferable. Only one tender shall be submitted by one bidder.
- 1.2 Bidders can submit the limited tender document in the downloaded form from this Institute website <a href="www.cltri.gov.in">www.cltri.gov.in</a> or Central Govt. Tender Portal <a href="http://etenders.gov.in">http://etenders.gov.in</a>.

## Earnest Money Deposit (EMD):

- 2.1 Earnest Money Deposit of Rs.10,000/- (Rupees Ten thousand only) by way of in the form of Account Payee Demand Draft drawn in Bank of Baroda or any nationalized bank payable at Chengalpattu, in favour of "The Director, Central Leprosy Teaching and Research Institute, Chengalpattu" should be submitted along with the tender document. The EMD in any other form will not be entertained.
- 2.2 Firms registered under NSIC, DGS&D & MSME Act 2006 and those firms which are registered with the District Industries Centre/Department of Commerce & Industries, Government of India & Tamil Nadu/any other State Governments which current validity are exempted from furnishing the Earnest Money Deposit (EMD). Otherwise, such bids without EMD will be summarily rejected.
- 2.3 Bidder shall not be permitted to withdraw his offer or modify the terms and conditions thereof after submission of the tender documents. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited by the Government.
- 2.4 No claim shall lie against the Government/Department in respect of erosion in the value or interest on the amount of earnest money deposit or security deposit. EMD will earn no interest.
- 2.5 EMD of unsuccessful bidder will be refunded only after finalization of tender selection and that of the successful bidder will be refunded after supply of the goods in question.

## Tender Withdrawal & Modification:-

Bidder shall not be permitted to withdraw his offer or modify the terms and conditions thereof after submission of the tender documents. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid amount of Earnest Money Deposit (EMD) will be forfeited and credited to the Government.

## 4. Preparation and submission of Tender:

(a) <u>Bid with Technical Specification</u>: The Technical bid specification Annexure-II in the given prescribed format should be submitted in a separate sealed envelope along with documents listed in Annexure – I of clause 12, superscribed with "TECHICAL BID".

- (b) <u>Bid with Price Schedule:</u> The Price Bid (Annexure-III) in the given prescribed format should be submitted in separate sealed envelope, superscribed with "PRICE BID"
- (c) The tender Technical Bid and Price Bid envelopes should be packed in a single sealed envelope super scribed with "Limited Tender (Two Bid System) for supply of Footwear articles— Limited Tender No.F 5-12/2021 CS " and addressed to "The Director, Central Leprosy Teaching & Research Institute, Govt. of India, Ministry of Health & Family Welfare, Chengalpattu 603 001, Tamil Nadu". The envelopes, which are not sealed, will be summarily rejected.

# Signing of Tender:

Individual signing the tender documents connected with contract must specify whether he sign as:

- a) A "sole proprietor" of the concern or constituted attorney of such sole proprietor.
- b) A partner of the firm, if it be a partnership firm, in which case must have authority to execute contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by executed by the partner of the firm.
- c) Director or a principal office duly authorized by the Board of Directors of the Company, if it is a company.

# 6. Important Conditions: -

- a) In case of partnership firms, a copy of the registered partnership agreement and if power of attorney is executed in favour of any or all the partners of any authorized officer of the firm to sign the tender document. Then, a copy of power of attorney duly executed by all the partners, sworn in before Notary Public should be enclosed.
- b) In case of partnership firms where no authority to refer disputes concerning the business of partnership firm has been concerned on any partner the tender and all other related documents must be signed by all partners of the firm.
- c) A person signing the tender form or any documents forming part of the tender on behalf of another person should have an authority to bind on behalf of such other person and if, on enquiry it appears that the persons so signing had no authority to do so, The Director, Central Leprosy Teaching & Research Institute may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages.
- d) In case of Private Ltd/Limited companies, Company Incorporation Certificate along with the Articles of Association has to be submitted.
