1. Eligibility: (As per existing Recruitment Rule of the post)
From amongst persons holding analogous equivalent posts under the
Central Government.

Educational qualification:

1. Passed Matriculation or equivalent.

2. Should have undergone 18 months training in a recognized reputed Institution in the manufacture of orthopaedic footwear appliances, splints, branches and artificial limbs.

Desirable:

- 1. Diploma in Physiotherapy issued by the Tamil Nadu Government or Equivalent qualifications recognized by Government of India.
- 2. Experience in orthotic work for leprosy patients.
- 2. List of Duties and Responsibilities attached to the post of Orthotic Technician at CLTRI are as under:
 - 1. Design and preparation of various types of specialised footwear like moulded insole, weight relieving calliper, pylon prosthesis ,Elephant foot, fixed ankle brace, etc for use by the leprosy patients.
 - 2. Taking of moulds, modification mounting of leather, bracing, riveting and final finishing related to preparation of special types of footwear's.
 - 3.To work on various machines like Drilling, Grinding, sheeting, shoe finishing yet. In connection with preparation of special footwear.
 - 4. Supervision of works of cobblers in the footwear section, who prepare different types of footwear for leprosy patients.
- The Period of deputation including the period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years.

- 4. The Maximum age-limit for appointment by deputation shall be 'Not exceeding 56 years' as on the last date of receipt of applications i.e., 01.10.2024.
- 5. Regulation of pay and other terms of Transfer on deputation:The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M No.6/8/2009-Estt. (pay-II) dated 17.06.2010 as amended from time to time.

- G.S.R. 757.—In exercise of the powers conferred by the provise to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to certain Group C Posts (Ministerial and non-Ministerial) in the Central Leprosy Training and Research Institute, Chingleput, namely:—
- 1. Short title and commecement.—(1) These rules may be called the Central Leprosy Training and Research Institute, Chingleput (Group C posts) Recruitment Rules, 1980.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Application.—These rules shall apply to the posts specified in column 2 of the Schedule Annexed to these rules.
- 3. Number, Classification and Scale of pay.—The number of posts, their classification and the scales of pay attached thereto shall be as specified in columns 3 to 5 of the said Schedule.
- 4. Method of recruitment, age limit, qualifications, etc.— The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 6 to 14 of the Schedule aforesaid.

5. Disqualification.-No person,-

- (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living, has entered into, or contracted a marriage with any person, shall be eligible for appointment to any of the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.—Where the Central Government is of opinion that it is necessary or expedient so to do, it may, be order for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class of category of persons.
- 7. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
